## Legislative & Public Policy Practice – Results & Outlook

The end of the 117<sup>th</sup> Congress in 2022 was one of the busiest legislative periods in recent history. Major legislation that became law included: The Inflation Reduction Act, the CHIPS Act, the Respect for Marriage Act, the James M. Inhofe National Defense Authorization Act for Fiscal Year 2023, the Ukraine Democracy Defense Lend-Lease Act of 2022, and two omnibus annual appropriations packages (for Fiscal Years 2022 and 2023). This document summarizes major legislative accomplishments the Legislative & Public Policy team secured for firm clients.

In 2023, the 118<sup>th</sup> Congress opens with a closely divided Congress, the House controlled by Republicans while the Democrats control the Senate and White House. It is easy to forecast a split Congress means legislative gridlock is likely, but the reality is more complex. Both parties have strong political incentives to show they can compromise and pass major legislation before the 2024 Presidential elections, and recent history shows a split-control Congress can muster the political will to do big things. At the very least, the policy debates of the next two years will go a long way to setting the parameters of major legislation to come when one party or the other regains total control of Congress.

# **2022 Accomplishments for Arnold & Porter Clients**

## Fiscal Year 2023 Appropriations

- \$915,000 for training, education, and pediatric mental health services at a children's hospital.
- \$750,000 for a university's mixed-use development.
- \$500,000 for an institution of higher education to build out a data science innovation hub, including funding for equipment and faculty hires.
- \$500,000 for youth behavioral health services and equipment at a children's hospital.
- \$400,000 for a non-profit organization working in coordination with an institution of higher education to implement a college completion program focused on women in STEM.
- Funding for additional slots for new graduate medical education (GME) eligible for Medicare payment and report language directing CMS to prioritize applications in FY 2023 from any hospitals seeking to establish or expand residency training in certain needed specialties, specifically including geriatrics.
- Bill language reauthorizing Child Nutrition programs that specifically acknowledges the importance of a
  university's implementation model for meal delivery services for summer meals and extends the demonstration
  project studying this model to allow more states to implement it.

- Secured language to reauthorize Child Nutrition programs that specifically acknowledges the importance of a client's implementation model for meal delivery services for summer meals and extends the demonstration project studying this model to allow more states to implement it.
- Mandated transparency into a Census Bureau project, including a requirement for the Bureau to brief Congress on the project.
- Secured an invitation on behalf of a university leader to participate in the White House Conference on Hunger, Nutrition, and Health.
- Prepared a university researcher to participate in a congressional hearing on increasing food access among older Americans.
- Drafted comment letters to the Department of Education and the Department of Health and Human Services related to the early care and education industry.

  mental health services provisions under Part B. This would enable 40 percent of the mental health workforce to
  provide counseling services to Medicare beneficiaries in various settings, including in office settings, skilled
  nursing facilities, rural health clinics, federally qualified health centers, and as members of hospice
  interdisciplinary teams.
- Averted a 10 percent rate cut for physicians participating in the Medicare program through offsetting increases in reimbursement rates to avoid significant reductions that the Medicare program would otherwise have imposed under its annual payment rule, and a waiver of otherwise applicable statutory budget control provisions.
- Helped secure relief for pending Physician Fee Schedule (PFS) pay cuts.
- Inserted favorable language regarding a provision addressing FDA regulation of certain products as drugs.
   Language originally included in earlier Senate HELP Committee-reported text would have had a negative impact on one of the client's top-selling products, but through our education and advocacy efforts, the final text in the omnibus omitted the problematic language.
- Coordinated a rapid response effort to a Centers for Medicare & Medicaid Services (CMS) coding and reimbursement issue that arose from the CY 2023 Hospital Outpatient Prospective Payment System (OPPS) and Ambulatory Surgical Center (ASC) Proposed Rule.



- Assisted an independent, nonprofit healthcare accreditation organization in its very first congressional relationship building efforts.
- Submitted comments and insight to the sponsors of diagnostic testing reform legislation, the Verifying Accurate
  Leading-edge IVCT Development (VALID) Act of 2021 (S. 2209 / H.R. 4128), highlighting the unique role that a
  client company plays as both a diagnostic test manufacturer and a clinical laboratory. Secured the inclusion of
  new language pertaining to Food and Drug Administration (FDA) guidance on diagnostic innovation, including
  in vitro clinical tests intended to address an unmet medical need, in a revised version of the VALID Act included
  in the Food and Drug Administration Safety and Landmark Advancements (FDASLA) Act of 2022 (S. 4348).
- Met with key Member offices and committee offices on issues related to R&D incentives, both in the tax space and the Medicare Part D space. Assisted the client company in strengthening its relationships with relevant congressional leaders.
- Aided a major manufacturer of healthcare products through a major acquisition, building support for the deal within both the Biden Administration and Congress, mitigating competition concerns, and preventing scrutiny that would otherwise undermine the deal.

- Drafted and secured favorable language on behalf of a military civilian sexual assault prevention nonprofit in the Fiscal Year 2023 NDAA that will require the Department of Defense to consider policy changes.
- Obtained revised language that makes important incremental steps towards creating a position within the Department of Defense to make legal resources more readily available to civilian sexual assault victims.
