### A LANDMARK CASE

*Gideon v. Wainwright* (1963)

The landmark U.S. Supreme Court decision affirmed that the Sixth Amendment’s guarantee of counsel is a fundamental right essential for ensuring a fair trial. It established that all criminal defendants, regardless of their ability to pay, are entitled to legal representation.
